

Is there a dress code?

Where do I park?

There will be a self-pay valet parking option on La Brea Avenue near the front entrance of the Jim Henson Company Lot at 1416 N. La Brea Ave. The cost is \$20 per car, paid onsite at the valet stand.

We strongly encourage ridesharing as an option, with drop off at the front entrance.

Hosted valet parking onsite is provided for Premium ticket holders, Anjou Pear ticket holders and event sponsors. The hosted valet stand will be located at the parking lot entrance on DeLongpre Avenue. Additional information will be sent prior to the event.

What do I do if using a rideshare service?

Due to the limited parking in the area, we strongly encourage ridesharing. Drop off for rideshare is at the main entrance of the Jim Henson Company Lot located at 1416 N. La Brea Avenue.

Lyft is generously offering a special code for the 2024 Spring Melt. This code allows \$15 toward your ride to the Jim Henson Company Lot on Saturday, April 20, it will only work for this location and date. Please see the information below:
